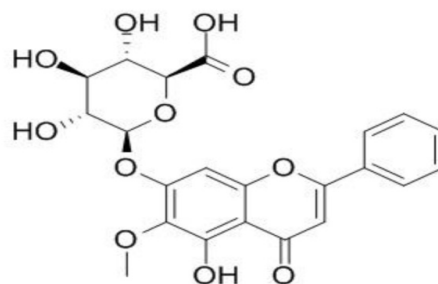

BIOLOGICAL ACTIVITY OR INHIBITORS

Oroxylin A-7-O-glucuronide and wogonoside should also be served as the chemical markers together with baicalin for the quality control of herbs and proprietary traditional [1]
Oroxylin A 7-O-glucuronide, Oroxin A, and Oroxin B can bind to the "stem" region of α -hemolysin (α -HL), when inhibiting the hemolytic activity of α -HL. [2]
Oroxylin A 7-O-glucuronide and 4',5,7-trihydroxy-6-methoxyflavone at a concentration of 100 microM inhibit 34 and 43% of total prolol oligopeptidase (POP) activity, respectively. [3]

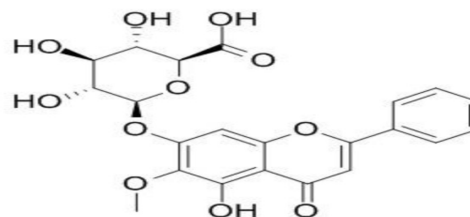
