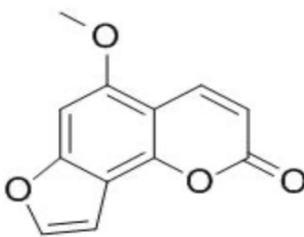

BIOLOGICAL ACTIVITY OR INHIBITORS

Isobergapten is a plant growth regulating substance. [1]

Isobergapten can suppress in vivo growth of *G. limeticola* and *B. cinerea*, it may form an important class of natural defensive agents against fungi.[2]

Isobergapten, a furocoumarin having a methoxy group, shows anti-proliferative activity and causes G2/M arrest at concentrations of 0.05-15.0 μ M, the anti-tumor actions of UVA plus furocoumarins having a methoxy group may be due to the arrest of the cell cycle at G2/M through an increase in phospho-Chk1 and reduction in phospho-cdc2. [3]

(3R,8S)-Falcarindiol, bergapten, isobergapten, angelicin, sphondin, pimpinellin, isopimpinellin and 6-isopentenylxyisobergapten are identified as the principal constituents responsible for the antimycobacterial activity of the roots of *Heracleum maximum*. [4]

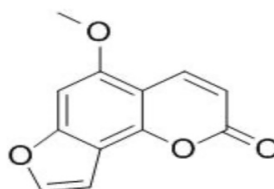
