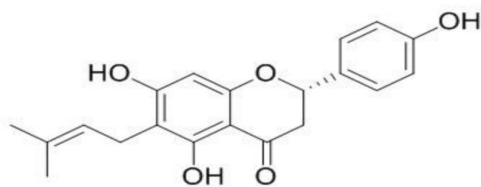

BIOLOGICAL ACTIVITY OR INHIBITORS

6-Prenylnaringenin is a chiral prenylflavonoid found most prevalently in hops (*Humulus lupulus*) and present in hops and hop products, it is an isomer of the potent phytoestrogen, 8-prenylnaringenin. [1]
6-Prenylnaringenin and 8-prenylnaringenin have anti-cancer potential , dose-dependent reduction of cellular proliferation of human PC-3 prostate cancer and UO.31 renal carcinoma cells upon treatment. [2]
6-Prenylnaringenin can inhibit 12-O-tetradecanoylphorbol 13-acetate (TPA)-induced inflammation (1µg/ear) in mice, it also exhibits inhibitory effects on skin-tumor promotion in anin vivo two-stagemouse-skin carcinogenesis test based on 7,12-dimethylbenz[a]-anthracene (DMBA) as initiator and with TPA as promoter. 6-Prenylnaringenin exhibits both mixed and non-competitive inhibitory characteristics against tyrosinase, tyrosinase is the rate-limiting enzyme for the production of melanin and other pigments via the oxidation of L-tyrosine. [4]

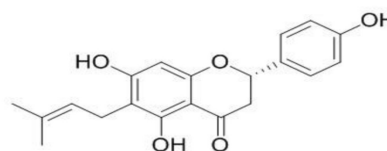
