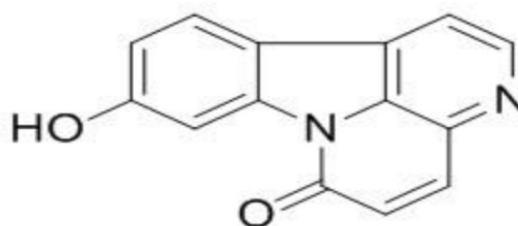

BIOLOGICAL ACTIVITY OR INHIBITORS

9-Hydroxycanthin-6-one (9-HC-6-one), a β -carboline alkaloid isolated from *E. longifolia*, it can induce penile erection and delays ejaculation; it may be the active component that contributed to the aphrodisiac effect of *E. longifolia* by antagonizing the smooth muscle tone of corpus cavernosum (CC) as well as seminal vesicle (SV) probably through interfering with Ca [1] 9-Hydroxycanthin-6-one is the first Wnt signal inhibitor through activation of glycogen synthase kinase 3 β without depending on casein kinase 1 α . [2] 9-Hydroxycanthin-6-one has cytotoxic activity against a panel of cell lines comprising a number of human cancer cell types [breast, colon, fibrosarcoma, lung, melanoma, KB and murine lymphocytic leukemia]. 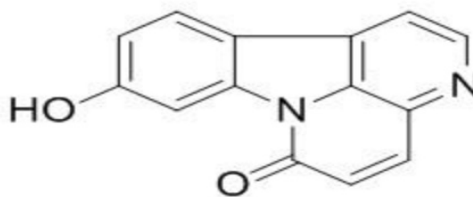
