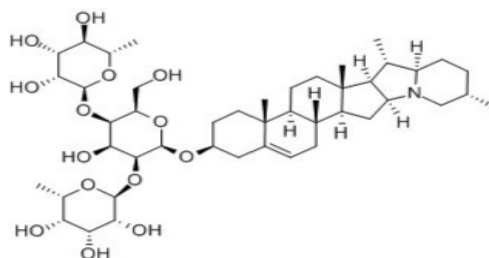

BIOLOGICAL ACTIVITY OR INHIBITORS

alpha-Chaconine and alpha-solanine have embryo toxicities [1]

Alpha-chaconine has various anticarcinogenic properties, it inhibits A549 cell metastasis by a reduction of matrix metalloproteinase-2 (MMP-2) and matrix metalloproteinase-9 (MMP-9) activities involving suppression of phosphoinositide 3-kinase/Akt/NF-kappaB (PI3K/Akt/NF-kappaB) signaling pathway. [2]

alpha-Chaconine has anti-angiogenic activity, it can inhibit migration, invasion and tube formation of bovine aortic endothelial cells (BAECs) by reducing MMP-2 activities, as well [3]

alpha-Chaconine has nematocidal activity, which is increasingly more toxic to a free-living nematode, *Panagrellus redivivus*, with decreasing acidity from about pH 5 to 7. [4]

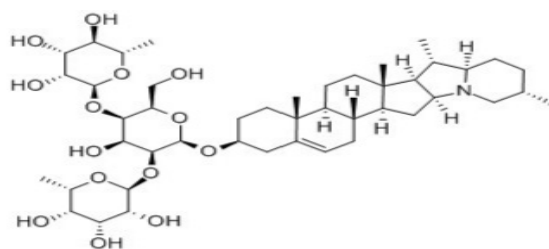
