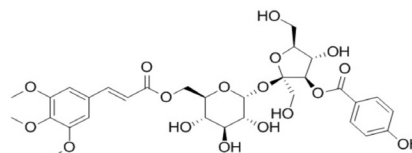

BIOLOGICAL ACTIVITY OR INHIBITORS

Tenuifolside A has neuroprotective effect, it induces neurite extension of PC12 cells and suggests that activation of the MEK/ERK/CREB and PI3K/Akt signaling pathways is involved in this process. [1]

Tenuifolside A protects C6 cells from CORT-induced damage, and the neuroprotective mechanism may be associated with the activation of Bcl-2 and suppressing Bax and the activity of Caspase-3 via ERK pathway. [2]

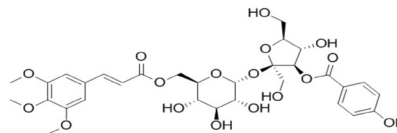
